## **TYPES OF MEMBERSHIP:**

There are nine categories of members.

(Current subscription fees for the 2023-2024 Hunt Season are in parentheses)

- 1. Sustaining Member (\$5,000.00)**
- 2. Family Member (\$4,000.00)**
- 3. Individual Member (\$3,600.00)**
- 4. Riding Social Member (\$850.00)**
- 5. Supporting Member (\$300.00)**
- 6. Junior Member (\$250.00)**
- 7. Pony Club Member (No Fee)**
- 8. Family Trial Member (\$2,000.00)**
- 9. Individual Trial Member (\$1,600.00)**

**Sustaining Membership** entitles the member to full family membership plus three capping fees to offer to guests during the hunt season. Sustaining Memberships with two adult members shall each have two votes – with each adult member casting one vote. A sustaining member is especially appreciated as their financial contribution helps secure the financial future of the Club.

**Family Membership** includes two adult riding spouses plus their children. However, any children who ride must be 25 years old or younger. Once a riding child attains age 26, he or she must pay an Individual Membership. Spouses with no children are eligible for a Family Membership. Family members with two adults have two votes – with each adult member casting one vote.

**Individual Membership** entitles one adult (age 26 or older) to ride in each hunt. An individual member has one vote.

**Riding Social Membership** would entitle the member to ride with South Creek Foxhounds eight (8) times during the season at any hunt of their choice without paying a capping fee (other than Opening Meet or any All Florida Meet Hunts). Riding Social Members are non-voting members. A Riding Social Member shall be required to notify the Field Secretary that he or she is utilizing one of their hunting days upon arrival at the Meet.

**Supporting Membership** entitles an individual and their spouse to attend all social events and attend the teas held after each hunt. A capping fee is required to attend any hunt. Non-Riding Members are non-voting members.

**Junior Membership** is only available to those individuals who are 25 years or younger on September 1<sup>st</sup> of the Hunt Season for which the membership dues are being paid.

**Pony Club Members** must be a member of a recognized Pony Club to be entitled to a waiver of any membership fees.

**Family and Individual Trial Membership:** These new categories are intended for anyone who has not been a member of SCF in the past but would like to give foxhunting a try. We are reducing our membership dues **for a two year period** to give you an

opportunity to join SCF at an Individual or Family membership level. Individual Membership is reduced to \$1,600.00 a year for two years. Family Membership is reduced to \$2,000.00 a year for two years. Thereafter, the dues payable will be whatever is the then subscription fees set forth by the hunt committee for that applicable season.

The reduced fees are only available to those who join for two consecutive years – for the 2023-2024 and the 2024-2025 seasons consecutively. If an individual or family joins for only the 2023-2024 season and then decides not to renew their membership for the next year, the reduced membership fee is no longer available to them. The two years must be the consecutive years of 2023-2024 and 2024-2025.

The reduced Family or Individual Trial Membership is not available to anyone who was previously a Sustaining, Family or Individual Member of SCF.

## **Additional Information:**

Capping fees are \$125.00 for adults and \$25.00 for juniors.

If you have not been a member of SCF, or another recognized hunt, we require you to cap 3 times before joining to be sure you and your horse enjoy foxhunting.
